An example of the cases was the arrest of Mary Figueroa for drug trafficking. Deputies found 10 baggies of white powder in her possession. The Deputies file was Cocaine and Fentanyl. The State tested the contents of the bags and the lab officially reported that there were no drugs in the bags. Yet Mary Figueroa's life was turned upside down. Several months later Lopez went before the press and denounced State Attorney Worrell
