UNITED STATES DEPARTMENT OF JUSTICE IN WASHINGTON SHERIFF MARCO LOPEZ UNDER ANOTHER INVESTIGATION...

The United States Department of Justice in Washington D.C. continues its investigation of Marco Lopez in the death of a 20 year old who was shot to death for a misdemeanor.

The 20 year old shop lifted \$40. of Pokémon cards and pizza from a target store. Lopez deputies, who were using the Target parking lot for a training exercise received a call that a shop lifting was taking place where the Lopez deputies were practicing tactics. The legality of using the Target parking was allegedly illegal because the Lopez deputies' were suppose to be using an Osceola property designated for deputy training but decided to use the target parking lot. Rather than detaining the young man as soon as he lefty the store, the Lopez deputies decided to let the shop lifter leave into the parking lot and get into his vehicle. At that point

the deputies decided to launch a vehicle blockade which resulted in deputies firing their guns at the youth and killing him.

On a TV interview with Fox news, Lopez said "we learn as we go that's the way we do it in Osceola". This statement supports the fact that Lopez, when he took office Lopez never reviewed Sheriff policies and

tactics. This meant that there was NO guidance to deputies on how to respond to a situation where a young man was shot to death for stealing pizza. The U.S. Department of Justice will soon determine if Lopez will be held responsible to this killing. In another case, Lopez has been charged and must appear in court and go before a Judge in December



appear in court and go before a Judge in December for the mishandling of evidence in the murder of Madeline Soto case.

Lopez also has a criminal record before he was a dispatcher at the Sheriff's office and used that job as an entry point to become a deputy. As a dispatcher there was no one looked into his back ground because he was already working at the Sheriffs office. Lopez has a felony arrest record for assault and also had to appear in court on 2 domestic violence cases.
