OSCEOLA COUNTY, Marcos Lopez was suspended as Osceola County Sheriff on Thursday after he was arrested on racketeering and conspiracy charges related to an alleged illegal gambling operation.

Gov. Ron DeSantis issued an executive order on Thursday removing Lopez as sheriff. DeSantis appointed Christopher Blackmon, Central Region Chief for the Florida Highway Patrol, to serve as interim Osceola County Sheriff. Blackmon, Central Region Chief for the Florida Highway Patrol,

Both the suspension and Blackmon's appointment were effective immediately.

Christopher Blackmon serves as chief of troops, overseeing Florida Highway Patrol's Troops C, D, and K in Orlando, Tampa, and the Florida Turnpike.

He also leads immigration-related operations across all 67 counties in Florida, according to Ron DeSantis' executive order.
