


WHAT WE STAND FOR:

Orlando Commissioner Arrested for FRAUD



ORLANDO, Fla. - Hill was arrested and booked into the Orange County Jail following a 13-month-long investigation from the FDLE and an indictment from a grand jury, which revealed that Hill allegedly took advantage of a 96-year-old constituent and used \$100,000 of her money to fund vacations, medical procedures and pay her bills.

"If they're true, they're awful allegations," Orlando Mayor Buddy Dyer said on Monday. "I'm just really shocked over the course of the last week, to learn about all of this."

On Monday, Gov. Ron DeSantis suspended Hill, but he added that she could return to office if exonerated.

"I think there's been a lot of buzz in that community. I think that there's a lot of problems, or a lot of concerning things with this conduct and this behavior, but that's for the courts to settle," DeSantis said during an appearance at the Greater Miami Expressway Agency.


Late Monday evening, Hill released a statement through the District 5 community email:
